



### **Market Summary**

The stock market on Wednesday remained bullish throughout the day and concluded the session in the green zone amid cement and steel sectors led the rally at the index and KSE-100 ended at yet another record high, settling at 67,756 after a gain of nearly 900 points. The Benchmark KSE-100 index made an intra-day high and low at 67,873.21 (986.95 points) and 66,985.01 (98.75 points) respectively while closed at 67,756.03 by gaining 869.77 points. PKR in today's interbank depreciated by Rs 0.0808 against USD and closed at Rs 277.9161. The value of shares traded during the day was Rs11.829 billion. Market capitalization stood at around Rs9.346 trillion. Overall, trading volumes for the day increased to 361.26 million shares compared with Tuesday's tally of 239.45million. WTL was the volume leader with 32.3 million shares, gaining Rs0.05 to close at Rs1.35. PIAA was the volume leader with 38.2 million shares, losing Rs1.86 to close at Rs25.22. It was followed by FLYNG with 21.5 million shares, gaining Rs0.89 to close at Rs8.79 and WTL with 21 million shares, gaining Rs0.03 to close at Rs1.38


