

## **Market Summary**


The stock market on Thursday opened on a positive note, followed by a correction in the second half and concluded the session in the green zone amid Pakistan and the IMF engaged in virtual discussions regarding the budgetary measures implemented to meet the criteria for a new bailout package. The Benchmark KSE-100 index made an intra-day high and low at 80,888.86 (655.19 points) and 80,134.89 (-98.78) respectively while closed at 80,282.80 by gaining 49.13 points. PKR in today's interbank depreciated by Rs 0.0947 against USD and closed at Rs 278.4973. The value of shares traded during the day was Rs19.318 billion. Market capitalization stood at around Rs10.611 trillion. Overall, trading volumes for the day decreased to 496.06 million shares compared with Wednesday's tally of 535.96 million. BOP was the volume leader with 29.3 million shares, gaining Rs0.13 to close at Rs5.53. It was followed by PIAHCLA with 26.7 million shares, gaining Rs1.52 to close at Rs18.46 and PAEL with 26.5 million shares, losing Rs0.23 to close at Rs26.52.
