






Market Summary


The stock market on Thursday maintained extremely bullish momentum throughout the day, gained 3,410 points in a single day, and concluded the session in the green zone amid optimism as IMF expresses satisfaction over budget 2024-25. The Benchmark KSE-100 index made an intra-day high and low at 76,338.14 (3,540.71 points) and 73,329.79 (532.36) respectively while closed at 76,208.16 by gaining 3,410.73 points. PKR in today's interbank appreciated by Rs 0.0164 against USD and closed at Rs 278.5919. The value of shares traded during the day was Rs30.693 billion. Market capitalization stood at around Rs10.132 trillion. Overall, trading volumes for the day increased to 633.59 million shares compared with Wednesday's tally of 292.92 million. KEL was the volume leader with 66.8 million shares, gaining Rs0.08 to close at Rs4.72. It was followed by FCCL with 39.8 million shares, gaining Rs1.87 to close at Rs24.14 and WTL with 21.8 million shares, gaining Rs0.04 to close at Rs1.33.
