

The stock market on Thursday remained negative in majority part of the day and concluded the session in the red zone amid profit taking by the investors. The Benchmark KSE-100 index made an intra-day high and low at 114,884.63 (388.93 points) and 113,630.45 (-865.25 points) respectively while closed at 113,836.74 by losing 658.96 points. PKR in today's interbank depreciated by Rs 0.0866 against USD and closed at Rs278.8561. The value of shares traded during the day was Rs24.963 billion. Market capitalization stood at around Rs14.086 trillion. Overall, trading volumes for the day decreased to 468.30 million shares compared with Wednesday's tally of 658.48 million. WTL was the volume leader with 103.7 million shares, gaining Rs0.06 to close at Rs1.86. It was followed by CNERGY with 37.1 million shares, losing Rs0.18 to close at Rs6.88 and DFML with 19.3 million shares,gaining Rs4.16 to close at Rs45.74.


