



Market Summary

The stock market on Monday remained positive for the majority part of the day and concluded the session in the green zone amid a reduction in the price of petrol and high-speed diesel. The Benchmark KSE-100 index made an intra-day high and low at 49,919.03 (426 points) and 49,317.59 (-176 points) respectively while closed at 49,731.35 by gaining 237 points. PKR in today's interbank appreciated by Rs0.99 against USD and closed at Rs276.83. The value of shares traded during the day was Rs 14.113 billion. Market capitalization stood at around Rs7.315 trillion. Overall, trading volumes for the day decreased to 467 million shares compared with Friday's tally of 342 million. KEL was the volume leader with 98.2 million shares, gaining Rs0.02 to close at Rs3.15. It was followed by PTC with 22.6 million shares, losing Rs0.17 to close at Rs6.95, and PIBTL with 22.1 million shares, gaining Rs0.42 to close at Rs4.59.


