

Market Summary

The stock market on Tuesday opened on a positive note. However, later on, it lost the impetus and reversed all of its intra-day gains while concluded the session in the red zone amid correction is anticipated in the market following the KSE-100 Index surpassing the psychological threshold of 50,000. The Benchmark KSE-100 index made an intra-day high and low at 50,017.45 (286 points) and 49,508.41 (-223 points) respectively while closed at 49,531.01 by losing 200 points. PKR in today's interbank depreciated by Rs0.2 against USD and closed at Rs277.03. The value of shares traded during the day was Rs 10.403 billion. Market capitalization stood at around Rs7.268 trillion. Overall, trading volumes for the day decreased to 368 million shares compared with Monday's tally of 467 million.
