### **Market Summary**

The stock market on Thursday Surged over 300 points and concluded the session in the green zone as IHC Orders Exclusion of Certain Income from Super Tax Calculation. The benchmark KSE-100 index made an intra-day high and low at 45,451.64 (357 points) and 45,067.95 (-27 points) respectively while closed at 45,398 by gaining 303 points. PKR in today's interbank depreciated by Rs1.35 against USD and closed at Rs285.15. The value of shares traded during the day was Rs10.104 billion. Market capitalization stood at around Rs6.883 trillion. Overall, trading volumes for the day increased to 464 million shares compared with Wednesday's tally of 243 million. WTL was the volume leader with 185.2 million shares, gaining Rs0.12 to close at Rs1.43. It was followed by BOP with 19.5 million shares, gaining Rs0.07 to close at Rs2.01.
