PKR in today's interbank appreciated by Rs1.02 against USD and closed at Rs291.76. The value of shares traded during the day was Rs 6.240 billion. Market capitalization stood at around Rs6.872 trillion. Overall, trading volumes for the day decreased to 170 million shares compared with Thursday's tally of 172 million. CNERGY was the volume leader with 10.6 million shares, gaining Rs0.11 to close at Rs3.09. It was followed by WTL with 10.1 million shares, losing Rs0.01 to close at Rs25.41.


Overall Sector Turnover (%)




