



Market Summary


The stock market on Tuesday remained volatile throughout the day and concluded the session in the green zone amid investors indulged in profit-taking in the second half of the session. The Benchmark KSE-100 index made an intra-day high and low at 79,585.34 (1,046.16 points) and 78,634.15 (94.97 points) respectively while closed at 78,987.09 by gaining 447.91 points. PKR in today's interbank depreciated by Rs 0.1072 against USD and closed at Rs 278.4072. The value of shares traded during the day was Rs17.067 billion. Market capitalization stood at around Rs10.447 trillion. Overall, trading volumes for the day decreased to 315.94 million shares compared with Monday's tally of 375.35 million. PIAHCLA was the volume leader with 22.1 million shares, losing Rs1.39 to close at Rs15.63. It was followed by PAEL with 19.8 million shares, losing Rs0.33 to close at Rs26.26 and WTL with 19.5 million shares, losing Rs0.01 to close at Rs1.17.


