




Market Summary

The stock market on Monday remained under selling pressure throughout the day and concluded the session in the red zone amid uncertainty regarding government measures in the upcoming budget. The Benchmark KSE-100 index made an intra-day high and low at 76,187.44 (204.41 points) and 75,485.62 (-497.41) respectively while closed at 75,517.48 by losing 465.55 points. PKR in today's interbank depreciated by Rs 0.0903 against USD and closed at Rs 278.3000. The value of shares traded during the day was Rs16.395 billion. Market capitalization stood at around Rs10.184 trillion. Overall, trading volumes for the day decreased to 445.49 million shares compared with Friday's tally of 609.78 million. KEL was the volume leader with 55.6 million shares, losing Rs0.19 to close at Rs5.02. It was followed by SYM with 40.7 million shares, gaining Rs0.69 to close at Rs6.19 and WTL with 29.5 million shares, losing Rs0.05 to close at Rs1.37
