




Market Summary

The stock market on Monday opened on a positive note and concluded the session in the red zone ahead of MPC meeting. The Benchmark KSE-100 index made an intra-day high and low at 73,300.75 (558.01 points) and 71,602.94 (-1,139.80) respectively while closed at 71,695.03 by losing -1,047.71 points. PKR in today's interbank depreciated by Rs 0.0093 against USD and closed at Rs 278.3976. The value of shares traded during the day was Rs26.307 billion. Market capitalization stood at around Rs9.820 trillion. Overall, trading volumes for the day increased to 612.85 million shares compared with Friday's tally of 540.77 million. HASCOLDEF was the volume leader with 60.1 million shares, gaining Rs0.58 to close at Rs8.11. It was followed by FFBL with 35.2 million shares, gaining Rs1.84 to close at Rs35.62 and PACE with 32.7 million shares, gaining Rs0.74 to close at Rs3.49
