

### **Market Summary**

The stock market on Thursday opened on a bullish note. However, later on, it lost the impetus and reversed all of its intra-day gains while concluded the session in the red zone as it couldn't sustain the psychological level of 49,000, even though there is a positive sentiment prevailing in the market. The Benchmark KSE-100 index made an intraday high and low at 49,404.50 (640 points) and 48,541.34 (-223 points) respectively while closed at 48,611 by losing 153 points. PKR in today's interbank appreciated by Rs2.18 against USD and closed at Rs287.20. The value of shares traded during the day was Rs19.003 billion. Market capitalization stood at around Rs7.289 trillion. Overall, trading volumes for the day decreased to 523 million shares compared with Wednesday's tally of 556 million. CNERGY was the volume leader with 33.2 million shares, losing Rs0.08 to close at Rs3.67. It was followed by KEL with 25.4 million shares, losing Rs0.01 to close at Rs2.35, and OGDC with 24.5 million shares, gaining Rs0.18 to close at Rs104.26.
