

Market Summary

Abbasi and Company (Private) Limited

The stock market on Friday Surged over 450 points and concluded the session in the green zone amid the caretaker finance minister held a meeting with IMF review mission led by IMF Chief Nathan Porter at the Finance Division. The Benchmark KSE-100 index made an intra-day high and low at 53,263.07 (606 points) and 52,782.21 (125 points) respectively while closed at 53,123.03 by gaining 466 points. PKR in today's interbank depreciated by Rs0.88 against USD and closed at Rs284.31. The value of shares traded during the day was Rs 15.583 billion. Market capitalization stood at around Rs7.675 trillion. Overall, trading volumes for the day increased to 509 million shares compared with Thursday's tally of 4733 million. KOSM was the volume leader with 43.2 million shares, gaining Rs0.27 to close at Rs2.26. It was followed by PRL with 41.8 million shares, gaining Rs1.08 to close at Rs22.65 and TPLP with 29.1 million shares, gaining Rs0.28 to close at Rs13.38.


