






### **Market Summary**

The stock market on Wednesday remained volatile throughout the day while concluded the session a bit above the last day's close. The benchmark KSE-100 index made an intra-day high and low at 45,438 (47 points) and 45,241 (-149 points) respectively while closed at 45,408 by gaining 17 points. PKR in today's interbank session appreciated by 1 paisa against USD and closed at 176.74. The value of shares traded during the day was Rs 10.284billion. Market capitalization stood at around 7.790 trillion. Overall, trading volumes for the day increased to 432 million shares compared with Tuesday's tally of 376 million. WTL was the volume leader with 75.6 million shares, gaining Rs0.19 to close at Rs2.36. It was followed by UNITYR3 with 66.8 million shares, gaining Rs0.79 to close at Rs2.27, and TELE with 23.8 million shares, gaining Rs0.65 to close at Rs17.96.
