




Market Summary

The stock market on Monday Surged over 700 points and concluded the session in the green zone amid growing confidence that the ongoing IMF review would be successful, in addition to the continuing company buybacks adding impetus to the market. The Benchmark KSE-100 index made an intra-day high and low at 53,944.89 (822 points) and 53,166.85 (43 points) respectively while closed at 53,860.36 by gaining 737 points. PKR in today's interbank depreciated by Rs0.98 against USD and closed at Rs285.29. The value of shares traded during the day was Rs 17.881 billion. Market capitalization stood at around Rs7.769 trillion. Overall, trading volumes for the day increased to 544 million shares compared with Friday's tally of 509 million. CNERGY was the volume leader with 68.1 million shares, gaining Rs0.26 to close at Rs4.11. It was followed by PRL with 37.3 million shares, gaining Rs0.65 to close at Rs23.3 and PIBTL with 34.5 million shares, gaining Rs0.7 to close at Rs5.51.


