
Market Summary

The stock market on Wednesday remained positive throughout the day and concluded the session in the green zone amid the expectation of investor friendly budget for capital market as news reports about the likely tax relief on inter-corporate dividends. The benchmark KSE-100 index made an intra-day high and low at 42,232 (308 points) and 41,924 (1 points) respectively while closed at 42,173 by gaining 219 points. PKR in today's interbank depereciated by Rs0.32 against USD and closed at Rs286.88. The value of shares traded during the day was Rs7.148 billion. Market capitalization stood at around Rs6.401 trillion. Overall, trading volumes for the day increased to 333 million shares compared with Tuesday's tally of 241 million. WTL was the volume leader with 79.6 million shares, gaining Rs0.07 to close at Rs1.22. It was followed by TELE with 16.6 million shares, gaining Rs0.13 to close at Rs4.39.


