Market Summary

The stock market on Friday remained negative in the first half of the day. However, it recovered earlier losses in the second half and concluded the session in the green zone amid uncertainty prevailing among the investors. The Benchmark KSE-100 index made an intra-day high and low at 85,750.18 (296.96 points) and 84,774.45 (-678.77 points) respectively while closed at 85,483.40 by gaining 30.18 points. PKR in today's interbank appreciated by Rs 0.1529 against USD and closed at Rs277.6379. The value of shares traded during the day was Rs26.107 billion. Market capitalization stood at around Rs11.155 trillion. Overall, trading volumes for the day increased to 560.50 million shares compared with Thursday's tally of 503.61 million. HUBCXD was the volume leader with 58.2 million shares, losing Rs5.83 to close at Rs106.9. It was followed by PTC with 51.4 million shares, gaining Rs1.18 to close at Rs15.7 and WTL with 45.7 million shares, losing Rs0.02 to close at Rs1.18.

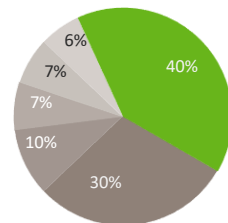

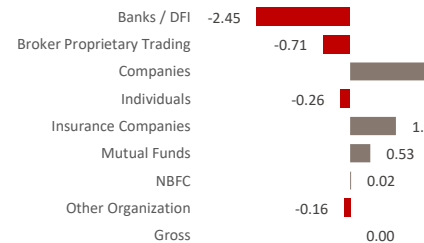
Overall Sector Turnover (%)

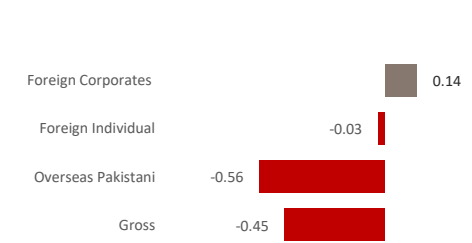

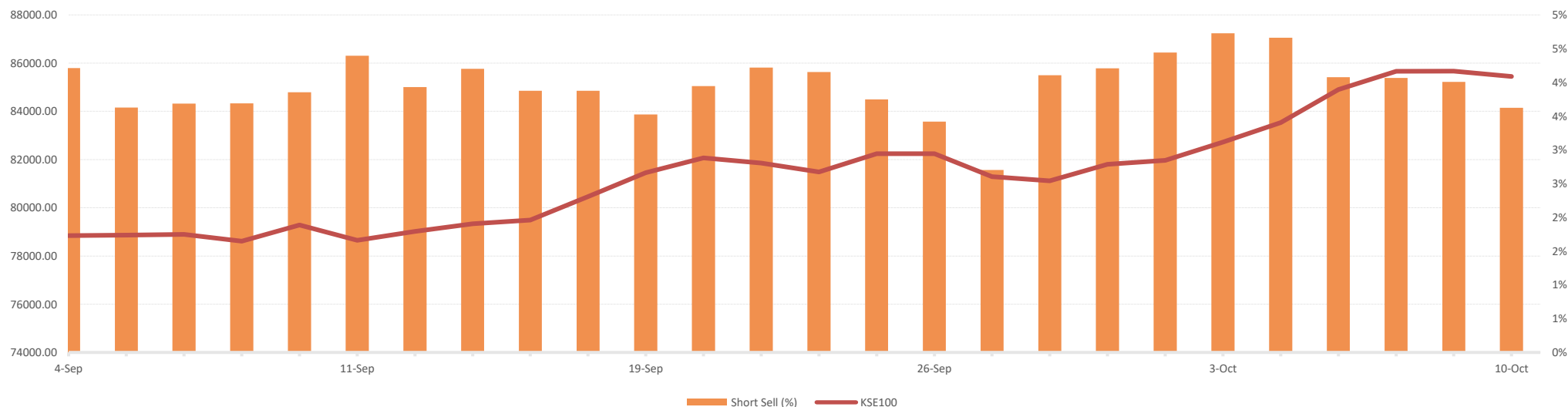
