Market Summary

The stock market on Wednesday remained volatile for the majority part of the day. However, near its closing, it gained momentum and concluded the session in the green zone. The benchmark KSE-100 index made an intra-day high and low at 43,098 (301 points) and 42,729 (-68 points) respectively while closed at 42,984 by gaining 187 points. PKR in today's interbank appreciated by Rs 0.5 against USD and closed at Rs 221.41. The value of shares traded during the day was Rs 6.645 billion. Market capitalization stood at around Rs 6.869 trillion. Overall, trading volumes for the day decreased to 185 million shares compared with Tuesday's tally of 189 million. UNITY was the volume leader with 19.4 million shares, losing Rs0.56 to close at Rs18.36. It was followed by HASCOLDEF with 16.1 million shares, gaining Rs0.25 to close at Rs8.04, and TRG with 11.5 million shares, gaining Rs7.49 to close at Rs148.33.

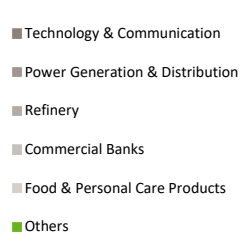

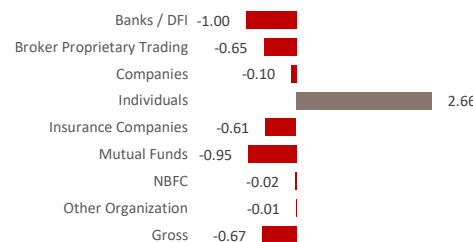

Overall Sector Turnover (%)

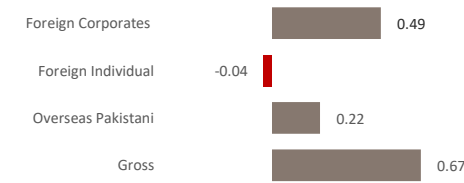

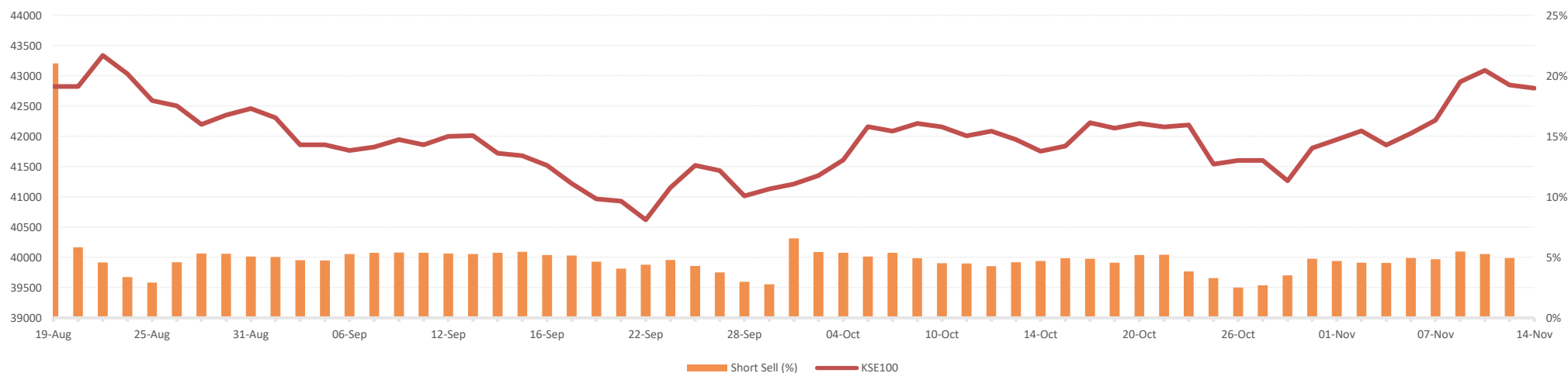
