Market Summary

The stock market on Thursday remained positive in the first half of the day, followed by a sharp decline in the second half and concluded the session in the red zone amid investors opted for profit-taking which prompted a surge in selling activity. The Benchmark KSE-100 index made an intra-day high and low at 66,196.23 (464.44 points) and 65,326.01 (-405.78 points) respectively while closed at 65,417.40 by losing 314.39 points. PKR in today's interbank appreciated by Rs 0.0137 against USD and closed at Rs 278.3953. The value of shares traded during the day was Rs11.307 billion. Market capitalization stood at around Rs9.210 trillion. Overall, trading volumes for the day increased to 389.64 million shares compared with Wednesday's tally of 341.67million. PTC was the volume leader with 52.9 million shares, losing Rs0.55 to close at Rs15.84. It was followed by PIBTL with 42 million shares, gaining Rs0.1 to close at Rs6.05 and BOPXD with 29.1 million shares, gaining Rs0.16 to close at Rs5.44.

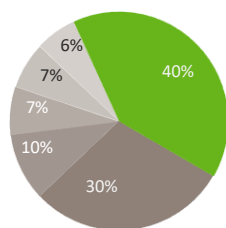

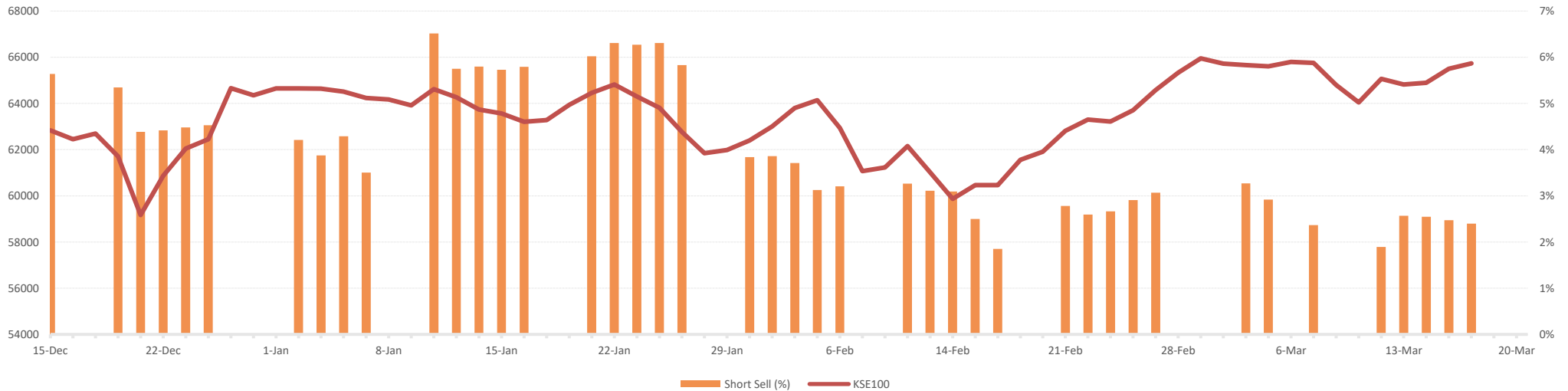
