Market Summary

The stock market on Wednesday remained positive in the first half of the day, followed by a decline in the last trading hours and concluded the session in the red zone amid profit taking by the investors. The Benchmark KSE-100 index made an intra-day high and low at 75,513.89 (307.12 points) and 74,835.48 (-371.29) respectively while closed at 74,956.67 by losing 250.10 points. PKR in today's interbank depreciated by Rs 0.0829 against USD and closed at Rs 278.4732. The value of shares traded during the day was Rs17.691 billion. Market capitalization stood at around Rs10.104 trillion. Overall, trading volumes for the day increased to 584.30 million shares compared with Tuesday's tally of 461.71 million. HUMNL was the volume leader with 71.3 million shares, gaining Rs0.13 to close at Rs12.03. It was followed by PACE with 46.6 million shares, gaining Rs1 to close at Rs4.32 and KEL with 34.5 million shares, losing Rs0.13 to close at Rs4.71

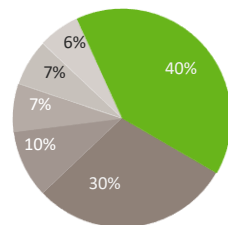

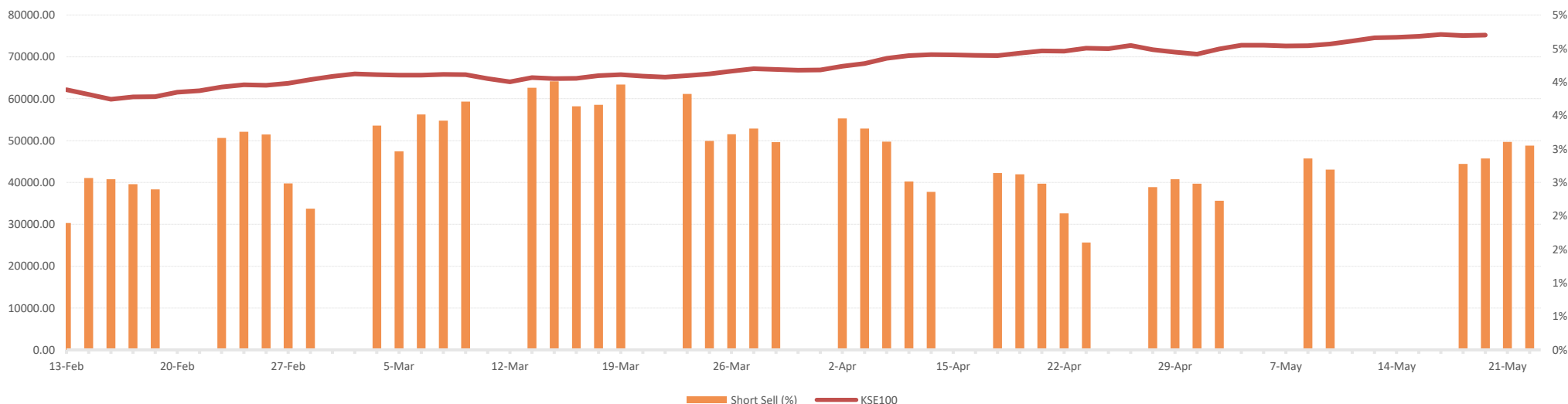
