

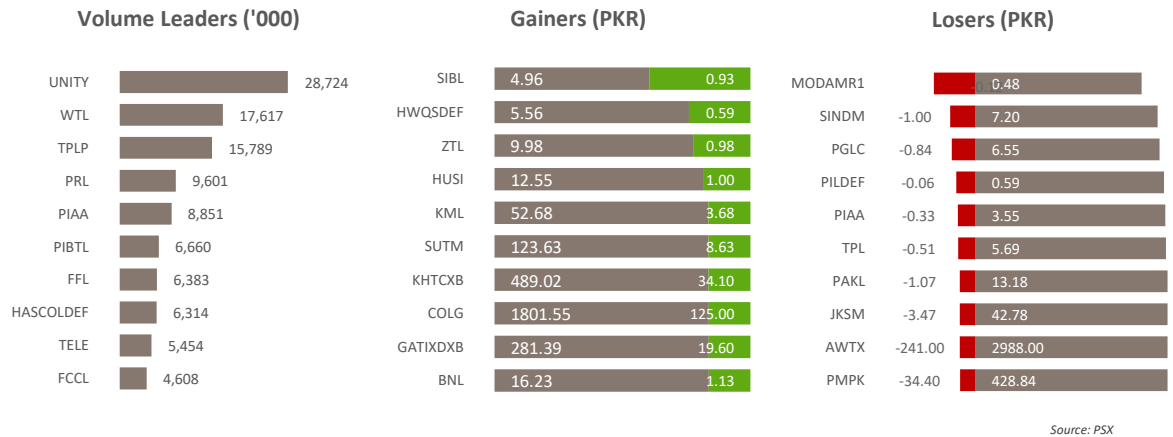

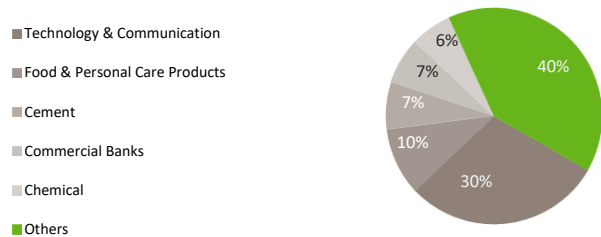

Market Summary

The stock market on Thursday plunged over 400 points and concluded the session in the red zone amid the political & macro-economic uncertainty ahead of the Fiscal Budget as IMF demand to pass program-friendly budget to unlock funds. The benchmark KSE-100 index made an intra-day high and low at 42,307 (164 points) and 41,649 (494 points) respectively while closed at 41,686 by losing 456 points. PKR in today's interbank appreciated by Rs0.07 against USD and closed at Rs286.81. The value of shares traded during the day was Rs5.848 billion. Market capitalization stood at around Rs6.367 trillion. Overall, trading volumes for the day decreased to 204 million shares compared with Wednesday's tally of 333 million. UNITY was the volume leader with 28.7 million shares, gaining Rs0.66 to close at Rs15.16. It was followed by WTL with 17.6 million shares, losing Rs0.04 to close at Rs1.18 and TPLP with 15.8 million shares, losing Rs0.14 to close at Rs12.83.

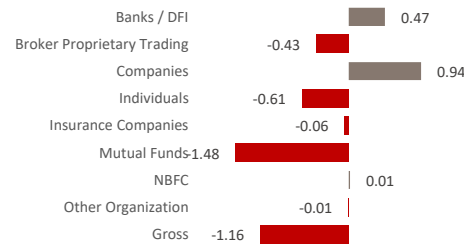


Overall Sector Turnover (%)

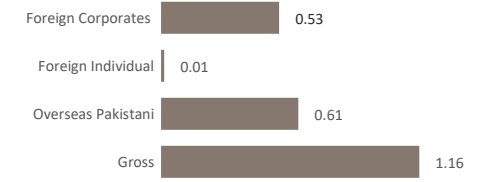

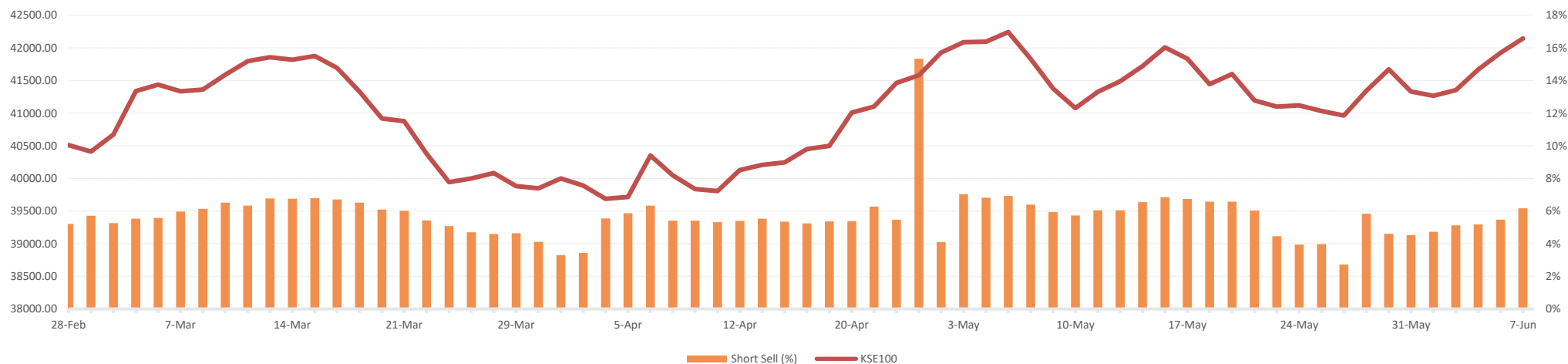
