



Market Summary

The stock market on Thursday surged past the 168,000 mark and concluded the session at a new all-time high amid optimism prevailing among the investors. The Benchmark KSE-100 index made an intra-day high and low at 168,619.32 (2,978.99 points) and 165,567.22 (-73.11 points) respectively while closed at 168,489.62 by gaining 2,849.29 points. PKR in today's interbank appreciated by Rs 0.0343 against USD and closed at Rs281.2710. The value of shares traded during the day was Rs 70.129 billion. Market capitalization stood at around Rs19.647 trillion. Overall, trading volumes for the day decreased to 1569.35 million shares compared with Wednesday tally of 1633.07 million. BOP was the volume leader with 148.1 million shares, gaining Rs2.98 to close at Rs32.78. It was followed by WTL with 133.9 million shares, gaining Rs0.12 to close at Rs1.82 and KEL with 116 million shares, losing Rs0.12 to close at Rs7.22.


