Market Summary

The stock market on Friday opened on a bullish note and concluded the session in the green zone amid expectations of a de-escalation in tensions between Pakistan and India. The Benchmark KSE-100 index made an intra-day high and low at 114,546.87 (3,220.30 points) and 112,820.07 (1,493.50 points) respectively while closed at 114,113.93 by gaining 2,787.36 points. PKR in today's interbank depreciated by Rs 0.0859 against USD and closed at Rs281.0594. The value of shares traded during the day was Rs23.270 billion. Market capitalization stood at around Rs13.806 trillion. Overall, trading volumes for the day decreased to 371.27 million shares compared with Wednesday's tally of 489.28 million. SSGC was the volume leader with 29.3 million shares, gaining Rs2.98 to close at Rs40.25. It was followed by CENERGY with 27.4 million shares, gaining Rs0.02 to close at Rs7.11 and BOP with 20.8 million shares, gaining Rs0.57 to close at Rs9.69.

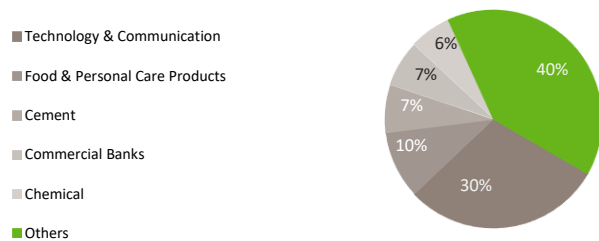

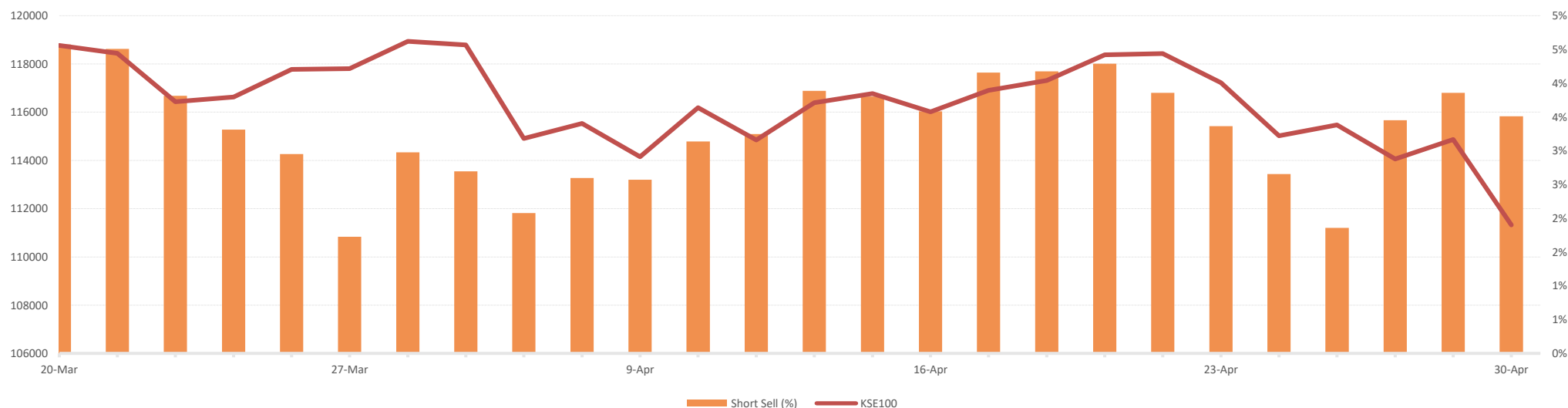
