


Market Summary

The stock market on Thursday maintained its buying rally, surpassed 146,000 mark for the first time and concluded the session in the green zone. Looking forward, with the stock market currently in overbought territory, a short-term correction is anticipated. As such, a cautious and selective approach is advisable. The Benchmark KSE-100 index made an intra-day high and low at 146,081.02 (992.53 points) and 145,250.17 (161.68 points) respectively while closed at 145,647.13 by gaining 558.64 points. PKR in today's interbank appreciated by Rs 0.1144 against USD and closed at Rs282.5578. The value of shares traded during the day was Rs55.561 billion. Market capitalization stood at around Rs17.374 trillion. Overall, trading volumes for the day decreased to 711.07 million shares compared with Wednesday tally of 784.33 million. PPL was the volume leader with 33.1 million shares, gaining Rs9.41 to close at Rs189.74. It was followed by WTL with 25.4 million shares, losing Rs0.01 to close at Rs1.43 and FFL with 24 million shares,gaining Rs0.28 to close at Rs16.04.
