Market Summary

The stock market on Tuesday remained negative throughout the day and concluded the session in the red zone amid profit taking by the investors. The Benchmark KSE-100 index made an intra-day high and low at 168,518.97 (766.57 points) and 165,997.21 (-1,755.19 points) respectively while closed at 166,173.74 by losing 1,578.66 points. PKR in today's interbank appreciated by Rs 0.0351 against USD and closed at Rs281.2188. The value of shares traded during the day was Rs 54.181 billion. Market capitalization stood at around Rs19.250 trillion. Overall, trading volumes for the day decreased to 1264.73 million shares compared with Monday tally of 1270.73 million. PTC was the volume leader with 180.6 million shares, losing Rs0.27 to close at Rs31.14. It was followed by BOP with 134.7 million shares, gaining Rs0.62 to close at Rs35.08 and CENERGY with 90.7 million shares, losing Rs0.03 to close at Rs8.76.

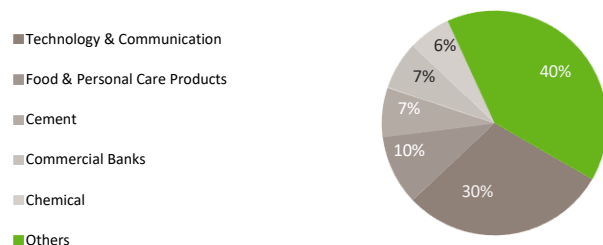

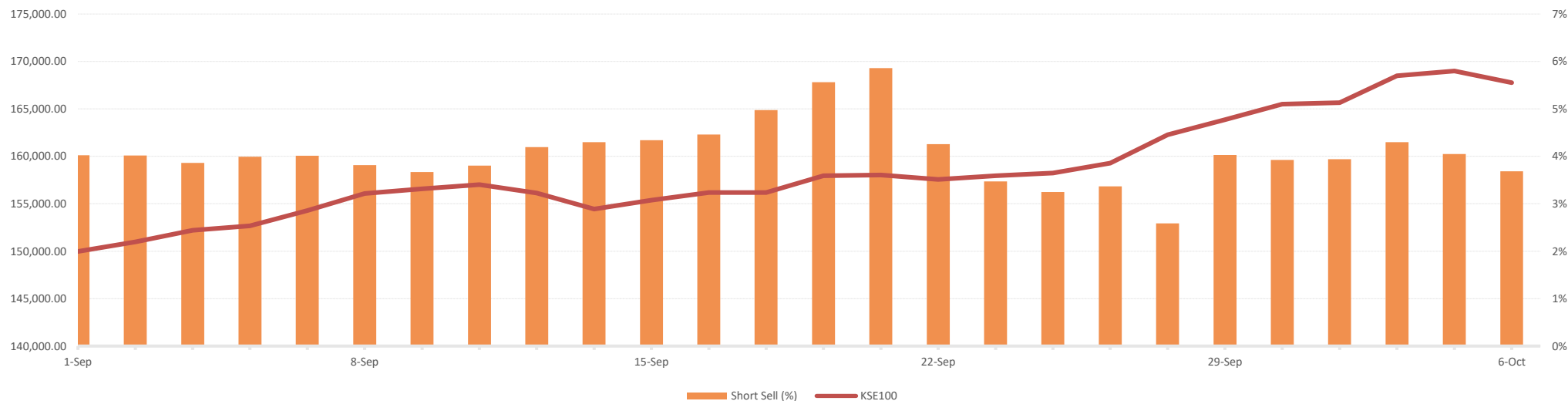
