

Market Summary

The stock market on Wednesday opened on a positive note. However, some of its earlier gains were eroded in the second half and concluded the session in the green zone amid positive sentiments prevailing among the investors. The Benchmark KSE-100 index made an intra-day high and low at 159,046.60 (1,101.58 points) and 158,133.30 (188.28 points) respectively while closed at 158,236.67 by gaining 291.65 points. PKR in today's interbank depreciated by Rs 0.0022 against USD and closed at Rs281.4250. The value of shares traded during the day was Rs 54.495 billion. Market capitalization stood at around Rs18.686 trillion. Overall, trading volumes for the day increased to 1779.52 million shares compared with Tuesday tally of 1519.35 million. KEL was the volume leader with 659.2 million shares, gaining Rs0.81 to close at Rs7.12. It was followed by CNERGY with 96.4 million shares, gaining Rs0.11 to close at Rs8.61 and PIBTL with 68.3 million shares, gaining Rs0.36 to close at Rs14.4.


